### **Exploring opportunities at Orana Youth Forum**

The Orana Youth Forum in November brought together more than 200 young people from around the Orana region to hear from business, industry leaders, universities, and training providers about the jobs and career paths of the future.

ASM and Toongi Pastoral Company (TPC) were delighted to participate in the inaugural event, taking an exhibition booth alongside more than 30 other organisations – all showcasing the many opportunities available.

Organised by <u>Regional Development Australia Orana</u> (RDA Orana), the Youth Forum targeted students in years 10, 11 and 12, with the objective of addressing the unique challenges faced by young people in today's competitive job market, and inspiring them in their decision-making.

TPC's General Manager Farming, Fergus Job, was on hand to speak to participants and provide insight into the work conducted at TPC and the planned operations at the Dubbo Project. The Dubbo Project mine and processing plant will support ~1000 jobs during the construction phase and up to 270 local jobs when operational.

RDA Orana has set a date for 26 August for the 2025 event.
