**Agenda Item 9            Proponent's Report**

---

In the absence of Ms Smith, Michael Sutherland provided an overview of the Proponent's presentation.

Mr Sutherland advised that ASM is still working with South Korean-based Hyundai Engineering to provide engineering, procurement and construction definition work (EPCD) for the Dubbo Project. He added that the focus is on delivering the two key projects - the Dubbo Project and the Korean Metals Plant. He noted that there is ongoing discussion in South Korea and the USA regarding further development of the business proposal.

Mr Sutherland advised that the Dubbo Project has received grant funding of \$500,000 under Stream 1 of the NSW Government's Critical Minerals and High-Tech Metals Activation Fund.

Mr Sutherland then provided a summary of the presentation given by Ms Smith to the ASM AGM on 28 November 2022. He focused particularly on the intention to build a rare earths and critical minerals business to provide high-tech metals needed to solve the challenges of today and the future. Mr Sutherland outlined the process of developing the Dubbo Project where the metals will be mined, separated and refined to high purity oxide products at Toongi, then transported to the Korean Metals Plant where the oxides will be metallised to high purity metals and alloys. These will be the the feed products for high performance magnets for various advanced applications in electric vehicles, wind turbines, solar panels and other high-end uses by global customers. He advised that ASM continues to work through opportunities with strategic investors and potential off-take customers.

Mr Sutherland advised that ASM has applied for a NSW Government's Critical Minerals and High-Tech Metals Activation Fund grant of \$10 million to support the undertaking of upgrades and roadworks on Obley Road involving the Hyandra Creek Bridge, 12 mile Creek causeway and Obley Road/Camp Road intersection. The overall cost of the works is \$20 million. The Camp Road intersection upgrades will support the future development of a function facility and additional accommodation infrastructure at the Taronga Western Plains Zoo.

Mr Sutherland provided the Committee with an update on progress of the Modification 1 Application. He advised the NSW Department of Planning & Environment has requested additional information on potential construction noise and clarification on a property purchase matter. He indicated responses are being prepared.

Mr Sutherland advised that the Dubbo-Toongi rail line (part of Country Rail Network) is now under the management of UGL Regional Linx which has taken over from John Holland.

Mr Sutherland that it had been a very busy time on the farm at Toongi with the recent rain causing difficulties both at Toongi and at Tomingley. Despite the wet weather he indicated wheat would be stripped at Toongi.

Mr Sutherland then provided a slide presentation on the Biodiversity Offsets at Toongi. His presentation focussed on the progress to date, providing a detailed update and highlighting various programs and initiatives, in particular work associated with managing and supporting the Pink-tailed Worm-lizard.

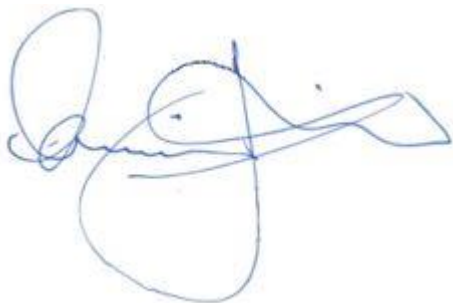
**Agenda Item 13      Next Meeting**
